CULLMAN COUNTY COMMISSION MEETING September 13, 2011

CALL TO ORDER AND WELCOME

Chairman James Graves called the Commission Meeting to order at 10:02 a.m. and welcomed the visitors.

<u>CALL OF ROLL TO ESTABLISH QUORUM, INVOCATION AND PLEDGE OF</u> ALLEGIANCE

Charlotte Slatton, County Clerk, called the roll; present were Chairman James Graves, Commissioner Darrell Hicks, Commissioner Stanley Yarbrough and County Attorney Heath Meherg. The invocation was given by Randall Waldrep. Sammie Danford led the Pledge of Allegiance.

APPROVE MINUTES OF THE AUGUST 23, 2011 MEETING, APPROVE APPROPRIATIONS, EXPENDITURES, REQUISITIONS, TRAVEL EXPENSES; AND APPROVE ALL JOURNAL ENTRIES TO BE POSTED.

Commissioner Yarbrough made the motion to approve the minutes from August 23, 2011 Commission Meeting, approve appropriations, expenditures, requisitions, travel expenses and approve all journal entries to be posted. Commissioner Hicks seconded the motion which passed on a unanimous voice vote.

PUBLIC COMMENTS

There were no public comments.

NEW BUSINESS

Public notification of Commission's plan for final debris removal

Chairman Graves stated FEMA and the Army Corps of Engineers have completed their debris clean up; however not all private property was cleared. The county will not be able to clear any private but property owners are asked to push vegetative debris to the right of way where the Road Department will pick it up the first week of October.

Discussion of the extension of grant application for individual storm shelters

Sammie Danford, Director of Economic Development, stated the deadline for application for individual storm shelters has been extended until October 27th. Federal funding for mitigation projects is currently on hold pending Congress' appropriations for the next fiscal year. Individuals wishing to make applications for storm shelter grants should have them in to the Economic Development Office by September 30th to insure review and arrival at the State EMA Office by the October deadline.

Ratify the agreement with F&O Architects, LLC for repairs/replacement of the courthouse roof

Commissioner Hicks made a motion to ratify an agreement with F&O Architects, LLC for the architectural design work of the roof replacement for the courthouse which was damaged in the

April tornado. Commissioner Yarbrough seconded. The motion passed on a unanimous voice vote.

Consider awarding the bid for the courthouse roof contingent on final settlement with the insurance company

Chairman Graves stated the Commission anticipates settling with the insurance company this week on courthouse damages from the April 27th tornado. Gary Teichmiller, County Administrator, stated Bonner Roofing and Sheet Metal Company of Savannah, GA submitted the low bid. Commissioner Yarbrough made a motion to award the bid to Bonner Roofing contingent on Travelers Insurance Company's settlement of damages. Commissioner Hicks seconded the motion which passed on a unanimous voice vote.

Authorize the Chairman to sign the 2012 NARCOG Aging Contracts

Chairman Graves stated these are the annual NARCOG aging contracts. The funding to the Commission on Aging will be less in 2012 due to the federal cuts. Commissioner Hicks made a motion to authorize the Chairman to sign the 2012 NARCOG aging contracts. Commissioner Yarbrough seconded. The motion passed on a unanimous voice vote.

Authorize the Chairman and County Administrator to sign the contract for the Youth Advocate Program funding through the Department of Youth Services

Brenda Howell with Juvenile Probation stated the grant is for \$211,000 which will fund the new program designed to have teams go into homes and work with the entire family of at risk teens. The program has a 35 year track record of success. Ms. Howell stated this will not cost the County any money. However, she requested the Commission appropriate funding for two months start up costs which will be reimbursed to the County once the grant money is received. The money will be released to the County quarterly from the grant and the Youth Advocate Program will bill the County. There will be no cost to the County; the County will only be the managing agent for the funds.

Mr. Teichmiller, County Administrator, asked if the grant would cover salaries. Ms. Howell stated it would cover a director and another full time employee and four to six part time (20 hour weekly) advocates. The grant would also cover the cost of office space and mileage reimbursement.

Commissioner Yarbrough made a motion to authorize the Chairman and County Administrator to sign the contract for funding through the Department of Youth Services. Commissioner Hicks seconded. Upon a unanimous voice vote, the motion carried.

Authorize the Chairman to sign the Long Term Detention contract with Tennessee Valley Youth Services

Chairman Graves stated the County has a contract with Tennessee Valley Youth Services for housing juveniles who remain in detention for over 72 hours. Commissioner Hicks made a motion to authorize the Chairman to sign the long term detention contract with Tennessee Valley Youth Services. Commissioner Yarbrough seconded the motion which passed on a unanimous voice vote.

Authorize the EMA Director to sign the SMORT grant for \$29,000 to be used for

equipment and training

Phyllis Little, EMA Director, stated the \$29,000 grant for State Mortuary Response Operational Response Team (SMORT) is a 100% grant for equipment and training. Commissioner Yarbrough made a motion to authorize the EMA Director to sign the grant. Commissioner Hicks seconded. The motion passed on a unanimous voice vote.

Authorize the Chairman and EMA Director to sign for the EMPG grant agreement FY 2011

Ms. Little stated this is the annual federal funding of \$49,672.00 for EMA. This year's grant carries requirement for extra training and a minimum of three field exercises. Commissioner Yarbrough made a motion to authorize the Chairman and EMA Director to sign the EMPG grant agreement FY 2011. Commissioner Hicks seconded. Upon a unanimous voice vote the motion passed.

Promoters anticipate drawing a large crowd to Cullman where attendees will be able to taste the BBQ entries. Organizers are hopeful this will become an annual event. Commissioner Yarbrough made a motion to make a \$5,000 donation to the Downtown Merchants Association for the tourism promotion of the KC BBQ Cook-Off. Commissioner Hicks seconded. The motion passed on a unanimous voice vote.

Commissioner Hicks made a motion to ratify all personnel actions. Commissioner Yarbrough seconded the motion which passed on a unanimous voice vote.

Chairman Graves address the meeting concerning Garden City's decision to purchase water from Blount County. For some time the disinfection byproduct (DBP) have been high at the Garden City site and would not meet ADEM standards for 2012.

Randall Waldrep, Water Department Manager, stated over the past several months steps have been taken to lower the DBP rate. DBP becomes high when water stays in storage tanks or waterlines for an extended period of time. Currently two water tanks have been taken off line and flush valves have been installed. These measures have brought the DBP level within acceptable range.

Chairman Graves stated he has been in contact with NARCOG, as they have personnel on staff that can assist with an evaluation, and with the City of Cullman who supplies the County's water. He stated the Commission will do everything possible to ensure all county residents have safe drinking water.

The next NARCOG meeting will be September 28, 2011 at the Decatur office of NARCOG.
