# Consider approval of three-year participation agreement with the ACCA Liability Fund for the period beginning January 1, 2018 and ending January 1, 2021

Gary Teichmiller, County Administrator, stated the County has been in the ACCA Liability Fund for several years. The ACCA is asking for a three-year participation agreement from participants in order to better manage the liability fund. The agreement will run from January 2018 to January 2021. Commissioner Watson made a motion to approve the of three-year participation agreement with the ACCA Liability Fund for the period of January 1, 2018 to January 1, 2021, Commissioner Marchman seconded and the motion passed on a unanimous voice vote.

#### Consider authorizing payment to the City of Hanceville for Mud Creek Cleanup in the amount of \$15,000

Mr. Teichmiller, County Administrator, explained the County has partnered with the City of Hanceville for a number of years on the maintenance of Mud Creek and the banks surrounding the creek. This is done to mitigate potential flooding in the area. Commissioner Marchman made a motion to approve the \$15,000 payment to the City of Hanceville for the Mud Creek cleanup. Commissioner Watson seconded. The motion passed on a unanimous voice vote.

## Consider renewal of three-year contract with Pitney Bowes for mail processing equipment- Monthly fee \$568.53

Mr. Teichmiller stated the new contract with Pitney Bowes will save the County approximately \$3,000 over the current agreement. Commissioner Watson made a motion to approve the renewal of a three-year contract with Pitney Bowes for mail processing equipment with a monthly fee of \$568.53. Commissioner Marchman seconded the motion which passed on a unanimous voice vote.
