Welds and fabricates parts and bodies as needed. Other duties as required.	
REQUIREMENTS FOR POSITION	<ul style="list-style-type: none"> • Must have knowledge of maintenance management including preventive and breakdown maintenance. • Must have knowledge of methods, materials, tools and standard practices of automotive and heavy equipment repair. • Ability to communicate effectively with Garage personnel, as well as employees of other departments. • Must have reading skills to understand technical literature, operator manuals and equipment blueprints. • Must possess a valid Class “A” CDL (or the ability to obtain one within one year of employment) and have a driving record that meets the standards set by the county’s insurance carrier. <p>This is a “safety-sensitive” position. Successful candidate must pass a pre-employment drug test and will be subject to random unannounced drug testing throughout employment with the County in a “safety-sensitive” position.</p>	
EDUCATION	Must possess a high school diploma or equivalent and 7 to 10 years experience in automotive and heavy equipment mechanic work, however, any combination of education and experience, which provides the necessary qualifications, will be considered.
