CULLMAN COUNTY COMMISSION MEETING MINUTES February 23, 2023

CALL TO ORDER AND WELCOME GUESTS

Chairman Clemons called the Meeting at 6:00 p.m.

CALL OF ROLL TO ESTABLISH QUORUM

Tiffany Merriman, County Clerk, called roll; present were Chairman Jeff Clemons, Commissioner Kerry Watson, Commissioner Garry Marchman, Commissioner Kelly Duke, County Administrator John Bullard, County Attorney Emily Johnston, and Assistant County Engineer Jon Brunner. Clarence Benefield gave the invocation. Colton Olinger from Welti School led the Pledge of Allegiance.

Commissioner Corey Freeman and County Engineer Bryan Cheatwood were not present.

APPROVE THE MINUTES OF THE JANUARY 10, 2023, MEETING, JANUARY 26, 2023, SPECIAL CALLED MEETING, APPROPRIATIONS, EXPENDITURES, PERSONNEL ACTIONS, PAYROLL, AND REQUISITIONS, AND APPROVE ALL JOURNAL ENTRIES TO BE POSTED

Commissioner Watson made a motion to approve the minutes of January 10, 2023, meeting, January 26, 2023, special called meeting, appropriations, expenditures, personnel actions, payroll, and requisitions, and approve all journal entries to be posted. Commissioner Marchman seconded, and the motion passed on a unanimous voice vote.

Chairman Clemons announced that we did not receive a request for public comments by the agenda deadline.

NEW BUSINESS

Recognition: Ashley Wilson named Farm City Family of the Year 2023 by the Cullman County Farm-City Committee

Chairman Clemons stated, "It is an honor to recognize you and we appreciate everything you do for the families in Cullman County."

Commissioner Duke made a motion to approve Recognition: Ashley Wilson named Farm City Family of the Year 2023 by the Cullman County Farm-City Committee. Commissioner Marchman seconded. The motion passed on a unanimous voice vote.

Ratify abatement for BBLU Inc./dba ProBin Global for the Town of South Vinemont in the amount of \$168.004.00

Cullman Economic Development Agency Project Manager Stanley Kennedy stated BBLU INC which does their business in the name of Probing Global, is located next to Perfection Chain in Vinemont. They are doing a 45,000-square-foot expansion, this company is only 3 years old. This company is looking for some abatement assistance with the rising cost of everything. This will create 4 new jobs with wages over \$20 an hour for these positions. The total of this investment of this project is \$2.5-\$2.6 million dollars. This is going to create \$94,000 plus in educational revenues over 10 years. The abatement amount is \$168,000 for the same period.

Commissioner Watson made a motion to Ratify abatement for BBLU Inc./dba ProBin Global for the Town of South Vinemont in the amount of \$168,004. Commissioner Duke seconded, and the motion passed on a unanimous voice vote.

Ratify abatement for Project Redesign for the City of Cullman in the amount of \$4,007,670

Cullman Economic Development Agency Project Manager Stanley Kennedy addressed the Commission and stated this project Redesign, is a project for one of our existing industries. The reason that it is under this name is due to it being a very competitive situation in a cut-throat market. This company is spending \$66 million trying to redesign their plant to compete with our new standards for the product they produce. Our community Cullman and our Cullman company is competing against out-of-state and out-of-town companies for the business tied to

this expansion. This expansion will create 50-plus jobs with wages over \$20 an hour, create \$57,000 plus a year in additional tax revenues to our community, and \$640,000 in local business revenues. During the 10-year period of this abatement, it will create over \$3.5 million dollars for community schools. This abatement will save them over \$4 million over the 10-year period.

Commissioner Watson made a motion to Ratify abatement for Project Redesign for the City of Cullman in the amount of \$4,007,670. Commissioner Duke seconded. The motion passed on a unanimous voice vote.

County Administrator John Bullard addressed the Commission and stated this is the American Rescue Plan Revenue production money, the \$1.2 million would go to purchase materials and our County forces will do the paving. This is to finish up roads that were remaining from last year's paving season.

Medicaid clients. This would not cost them anything out of pocket. It would be paid by their insurance or Medicaid.

Chairman Clemons stated this will be great for our seniors and veterans.

Commissioner Marchman asked does it have to be Medicaid?

CARTS Director Joyce Echols, no. It is insurance or Medicaid, it may be Medicare as well but I am not sure about that. If they have insurance that will cover their transportation then we will be able to provide for them. Commissioner Marchman stated is this just in Cullman County?

CARTS Director Joyce Echols said that is the way it is stipulated.

Commissioner Marchman stated is it stipulated by our design, or did they design it? We have local veterans that we are trying to help outside of Cullman.

County Administrator John Bullard stated, I think that is the stipulation that they have to live in Cullman County. This is just the application, there is nothing that I can see that says it only has to be in Cullman County.

CARTS Director Joyce Echols stated some other agencies are already doing it like Baldwin County and it has been great.
