The pipe shall be at a minimum length of 20 feet (for sloped end pipes this length is required before the sloped section begins) and a maximum length of 60 feet unless approved by County Engineering Personnel. Pipe material shall be Reinforced Concrete, High-Density Polyethylene (HDPE), Grey Plastic (Polypropylene) or Galvanized Corrugated Metal (15" to 30" 16-gauge minimum, 36" to 42" 14-gauge minimum, 48" to 54" 12-gauge minimum, 60" to 96" 10-gauge minimum). The appropriate headwalls, if required shall be installed at a 2:1 maximum slope.

Applicant requesting the driveway must mark the location of the center of the proposed access point with white flagging ribbon or other identification markers. An employee of the Road or Engineering Department will inspect the proposed location. Once approved, the applicant will be contacted with the size pipe needed. After installation an employee of the Cullman County Road or Engineering Department will inspect the installation. Any pipe that is installed incorrectly or without a proper permit is subject to removal. Please return application to address above or e-mail fspeake@co.cullman.al.us. The applicant must call (256)796-1336 to schedule an inspection of proposed location prior to the placement of pipe.

I, the undersigned, will comply with all conditions, restrictions and regulations of the pipe policy of the Cullman County Road and Engineering Department related to the installation of the proposed driveway and pipe stated in this permit. I hereby assume all liability and hold harmless Cullman County from any and all claims for damage arising out of the work to be done herein, any damage done by the continued use of the driveway and pipe, and any repairs, maintenance, or upkeep related to the driveway pipe. I also agree to repair any damage to the driveway pipe that creates drainage issues on Cullman County Right of Way.
